5. Content of cause explanation:

5.1. Cause for Profit after corporate income tax Quarter IV 2024 changed by over 10% compared with the same period in 2023:

Profit after corporate income tax Quarter IV 2024 in Combined Financial Statements of Vinaconex-ITC is negative 5,92 billion VND, increasing in loss compared with the same period in 2023. The main causes indicator profit after corporate income tax of the current period changed by over 10% is that revenue and cost of goods sold are recorded less than those in the same period in 2023 because The company is currently focusing all resourses on investing in the Cai Gia, Cat Ba Tourism Urban Area Project, so there are not much products to bring to the market, so revenue is low and decreased compared with the same period in 2023.

5.2. Cause for Profit after corporate income tax Quarter IV 2024 is lost:

In the fourth quarter of 2024, although the Company recorded revenue from business activities, that was not enough to cover the Company's costs causing profit after corporate income tax in the fourth quarter of 2024 is lost.
